NOTIFICATION OF LIMITATIONS TO FOLLOW: PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY.

These Terms and Conditions govern the relationship between you and Just Roughin' It Adventure Company LLC, (hereinafter referred to as "the Company" or "Just Roughin' It"). By booking a trip, you agree to be bound by these Terms and Conditions which outline, among other things, our cancellation policy and certain limitations of liability. These Terms and Conditions affect your rights and designate the governing law and forum for the resolution of any and all disputes.

Registration Form/Waiver:

All signature and information pages of this form/waiver (pages 1, 4, 5, 6 & 7) are due within 30 days of your 50% deposit paid date or upon receipt of this form if your trip departs in less than 30 days. Failure to complete the form by the deadline may result in a late fee or forfeiture of your trip and any monies paid to the Company. You will not be able to participate in any Just Roughin' It trip without a registration form/waiver on file with the Company.

Trip Payment and Guest Cancellation Policy:

A non-refundable deposit of 50% is due upon the booking of a trip. The balance is due no later than 30 days before the date of departure. Failure to pay balance by the due date may lead to forfeiture of your spot and your deposit will not be refunded. No refunds will be issued after 30 days before your departure date. The Company has a strict non-refund policy. Any monies paid to the Company to book a trip, will not be refunded, nor can the amount be transferred to another paying guest or to a different trip. Once your spot(s) is booked, no transferring or rescheduling of dates is permitted. We strongly recommend travel insurance to cover you in the event you need to cancel or reschedule your trip.

Travel Insurance:

Because JRI trips are non-refundable nor non-transferrable (as specified above), we highly recommend you carry at least a basic travel insurance package. Due to the nature of adventure travel and the unforeseen circumstances that can occur, this would be a wise course to consider for your medical and financial well-being as well as peace of mind while away from home.

Unused Services:

There will be no discounts or monies refunded for missed or unused services, this includes voluntary or involuntary termination. (i.e.: sickness, death of a family member, work, etc.)

Cancelled Trips:

The Company reserves the right to cancel any trip before it is guaranteed to run, but will not cancel a tour less than 30 days before departure. A trip is guaranteed to run once it has two fully-paid travelers, unless minimum numbers state otherwise. The Company reserves the right to cancel or reroute any trip, including a guaranteed trip, at any time prior to departure or once the trip has commenced due to terrorism, natural disasters, political instability or other external events which make it unviable for the Company to operate the planned schedule. The Company is not responsible for any incidental expenses that you may have incurred as a result of your booking such as visas, vaccinations, nonrefundable flights or loss of enjoyment, etc.

Privacy Policy: Any information, medical or otherwise, obtained by Just Roughin' It is treated as privileged and confidential and will not be released or revealed to any person other than the trip leader without your expressed written consent. Medical information is only released to a trip leader when the information given is necessary for the proper administering of first aid.

Responsibilities of guest participation on trips:

Trip guests have certain responsibilities to the trip leader and other guests. Just Roughin' It Adventure Company LLC. guests are responsible for understanding fully that the conditions of the particular trip they have decided to join. This is especially true of our "strenuous rated adventures". At all times the decision of the Company's tour leader or representative will be final on all matters likely to endanger the safety and well being of the tour. By booking with us the Client agrees to abide by the authority of the tour leader, who represents the Company. If the Client is affected by any condition, medical or otherwise, that might affect other people's enjoyment of the tour, the Client must advise Just Roughin' It at the time of booking. Should the Client fail to comply with the above or commit any illegal act when on the tour or, if in the opinion of the tour leader, the Client's behavior is causing or likely to cause danger, distress or annoyance to others, we may terminate that Client's tour without any liability on the Company's part and the Client will not be entitled to any refund.

Drug and Alcohol Policy:

Illegal drugs will not be tolerated on any trips. Additionally, the consumption of alcohol during the trip is prohibited. Anyone suspected to be under the influence of alcohol or drugs will not be allowed to participate in the trip. Our group leader has the right to expel any member of the group if illegal drugs or alcohol are found in their possession or is found to be in violation of any part of this policy.

Smoking Policy:

Smoking is prohibited during any activities offered by Just Roughin' It Adventure Company. Smoking is allowed once activities have concluded for the day or while taking a break from any activity. Please be courteous of everyone around you and smoke away from other people on the trail or in the campgrounds. Any waste produced by cigarettes are considered trash and must be carried out. Due to the arid climate, most areas of Arizona run at a moderate to high forest fire risk most of the year. Smoking in the wilderness can pose serious danger to all members of a trip due to this fire risk.

Health:

You should consult your doctor for up-to date medical travel information well before departure. We recommend that you carry a First Aid kit as well as any personal medical requirements. Please be aware that quite often we are in remote areas and away from medical facilities, and for legal reasons our leaders are prohibited from administering any type of drug including headache tablets, antibiotics, etc. When selecting your trip please carefully read the brochure and itinerary and assess your ability to cope with our style of travel. It is of the utmost importance that persons with medical problems notify us upon sign-up or well before the trip departure. Just Roughin' It Adventure Company LLC. reserves the right to exclude any traveler from all or part of a trip without refund if in the reasonable opinion of our group leader they are unable to complete the itinerary without undue risk to themselves and/or the rest of the group. It is of the utmost importance that persons with medical problems notify us upon sign-up or well before the trip departure.

Flexibility:

The Client appreciates and acknowledges that the nature of this type of travel requires considerable flexibility and should allow alternatives. The itinerary provided for each tour is merely representative of the types of activities contemplated, and the Company is under no contractual obligation to strictly follow it. It is understood that the route, schedules, itineraries, amenities and mode of transport may be subject to alteration without prior notice due to local circumstances or events, which may include sickness or mechanical breakdown, flight cancellations, strikes, events emanating from political disputes, entry or border difficulties, climate and other unpredicted or unforeseeable circumstances. For example, we cannot guarantee you will make a flight or any other appointment scheduled on the same day as the last day of your trip itinerary. This means we are not responsible for any fees associated with any missed flights or appointments.

Factors Outside the Company's Control (Force Majeure):

The Company shall not be liable in any way to the Client for death, bodily injury, illness, damage, delay or other loss or detriment to person or property or for the Company's failure to commence, perform and/or complete any duty owed to the Client if such death, delay, bodily injury (including emotional distress or injury), illness, damage or other loss or detriment to person or property is caused by Act of God, war or war like operations, terrorist activities, civil commotions, labor difficulties, whether or not Company is a party thereto, interference by authorities, political disturbance, how so ever and where so ever any of the same may arise or be caused, riot, insurrection and government restraint, fire, or any other cause whatsoever beyond the control of our Company.

Equipment:

The Client is aware that they are paying for the use of Company property and said property is to be returned at the conclusion of the service provided by the Company. The Client will be charged for the replacement of any lost or missing gear, as well as damaged gear that is damaged beyond normal wear and tear or damaged due to the Client's negligence. Any items left behind by the Client after the conclusion of the Company's service, will incur a minimum service fee of \$20 for returning said items.

Personal Belongings:

The Company is not liable for the theft, loss or damage of any personal belongings of the Client during the duration of a Just Roughin' It trip. This includes any items left behind in the vehicles or left to be stored by the Company. The Company will handle and store small bags (airline carry-on size or smaller) belonging to the Client for no additional charge. Any large and/or heavy bag(s) (any bag you would have to check in to an airline) will be charged a \$15/bag handling fee.

Just Roughin' It Adventure Company reserves the right to refuse participation in any of the company's activities. The company also reserves the right to cancel a trip at anytime and the company's judgment is final.

I, _____, HEREBY ACKNOWLEDGE that I am aware that during the mountain, canyon, or road trip vacation or expedition I am participating in, certain risks and dangers may arise, including and not limited to, the hazards of traveling in mountainous terrain, high altitude, undeveloped areas by hiking, automobile, the forces of nature, civil unrest, terrorism and accident or remote regions without means of rapid evacuation or availability of medical supplies and facilities.

I acknowledge that the enjoyment and excitement of adventure travel is derived in part from the inherent risks incurred by travel and activity beyond the accepted safety of life at home or work and that these inherent risks contribute to such enjoyment and excitement, being reason for my participation. I am fully aware, and clearly understand, that Just Roughin' It Adventure Company LLC, will have no liability regarding the adequate condition of any medical care, equipment or supplies that may be provided. I agree that if I am injured or become ill, Just Roughin' It Adventure Company LLC, may, at my cost, arrange or supply medical treatment, evacuation or any other medical services necessary on my behalf and what Just Roughin' It Adventure Company LLC, deems essential for my safety and well being.

I am voluntarily participating in these activities with the knowledge of the dangers involved and hereby accept responsibility to assume any and all risks including injury and death.

If any equipment, or automobile owned by Just Roughin' It Adventure Company LLC is damaged through my negligence, then I will be responsible for the repair or replacement costs. Furthermore, if any public or private property or land is damaged, animal is injured or killed, or any person is injured or killed as the result of my negligence during the scope of the trip, then I will be responsible for any repair, replacement, medical and other associated costs.

This Release of Liability and Assumption of All Risks agreement is entered into on behalf of all members of my family. This agreement is binding on my heirs, legal representatives and assigns.
